A NEW AUTHORITY FOR PI'S AND SECURITY PROFESSSIONALS IN FRANCE

The most important information in the recent months in France is the creation of a new control body for private security. The Conseil National des Activités Privées de Sécurité (CNAPS) or National Council for Private Security is a public organization with administrative police power.

It was created last year and has come into effect in France starting January 2012. New licenses are being granted little by little.

Just like the UK SIA, its purpose is to control and regulate all private security activities : private investigation, fund transport, guarding & body guards.

The CNAPS will take over the regional Prefects in order to:

- control these activities
- deliver professional licenses
- deliver a new national professional card
- write a common code of ethics for all these activities
- take disciplinary actions

CNAPS is composed of State officials (Judges + Police) as well as delegates of the professionals, among which is one private investigator. This body elects its President.

It includes a special commission for licensing and control. A two year college degree is now imperative to settle a P.I. business in France

CNAPS, as the SIA, is financed by the professionals through a new tax of 0,5% on domestic business.

It will be collected the same way VAT is.

We are proud to announce that the sole private investigator's delegate nominated is Mr.

J.E. Derny, the current President of our professional association (SNARP).

Prefect J.L. Blanchou was nominated as Président of CNAPS.
